### **CHAPTER I**

#### INTRODUCTION

## 1.1 Background of the Study

Littlewood (in Fanggidae 2011: 3), stated that by making errors learners will build their new knowledge to use target language. It means that making errors during studying the second language can be considered as a means of building learners' abilities. Making errors is a natural and unavoidable part of the process of learning English. Many kinds of errors arise when the learners write because they do not master the English structure well.

Also, error is the inability of the students in using rules of the components and elements of the second language. The learners often make mistake and even errors in learning, especially when they try to arrange sentences or use tenses in their writing. As a result, they will write sentences ungrammatically. Actually, ungrammatical sentences have great influence when the learners are writing sentences that can be influenced by the first language. Students' errors are very useful ways of showing what they have not learnt.
