### **CHAPTER V**

### **5.1 Conclusions**

- 2. The level of students ability is classified is "very good" (13.5).

There are some errors committed by the students in grammar and vocabulary as has been described in chapter IV dealing with form, in general students applied the generic structure of descriptive text namely identification and description. Besides, almost all of them use simple present tense correctly.

# **5.2 Suggestion**
