CHAPTER I

INTRODUCTION

1.1 Background

Many people consider that literature is just an imaginative crave that is written to persuade, entertain, or it just a work of artists and authors to make some money. They believe that literature is not only a work of imagination but a selection from facts of the world or the way of making up certain facts in order to present a truth or human nature (Risdianto, 2011:7). Supporting this statement, there are three classifications of literature theories; imitative, expressive and affective (Risdianto, 2011:7) which become model to understand literary works. An author and artist cannot make a work of literature without knowing something firstly as a model to make it new or feeling something inward before express it outs and seeing something before that effects his personal life to judge the world.

However, literature is not only a work of imagination but the combination between the existences inward (feeling or emotion) or outside (stimulus) with the imagination of the authors or artists to create the nature of human (ibid).

By several descriptions above, the writer has proposed her research in the field of literature especially in the work of prose fiction. She believes that what is telling in the story is not only the imagination of the author yet thing that familiar with him who makes him pour out into his writings.

1.4 Scope and Limitation

In analyzing literary works in this case short story, there are two elements that are often being analyzed those are intrinsic and extrinsic features of story. Intrinsic features are divided into seven parts: character, plot, setting, theme, point of view, style, and tone (Risdianto, 2011). Extrinsic features divided into several parts; biography, society, psychology, thought or idea, and other arts (Wellek and Warren, 1949). Sometimes another additional part is included like cultural and historical context but they are divided from previous parts.

In this study, the writer analyses the extrinsic factor of story specifically in the context ofpsychology of the writer and how it affects the writing of the story.

1.5 Definition of Terms

In order to make the readers understand more clearly about this study, the writer gives explanation regarding some particular terms that used in this study.

1. Analysis

Analysis is the practice of looking closely at small parts to see how they affect the whole (Bartle &Sherbert, 2009). The analysis here refers to the practice of the writer to see closely the psychology of the author's that affects the buildings of his story.

2. Psychology

Oxford Dictionary offers two definitions of psychology those are "the scientific study of human mind and its functions, especially those affecting behavior in a given context and the mental characteristics or attitude of a person that governing the situation and activity". In this study, the writer brings the psychology into art or psychology of art where the author who is the one who writes a story not only giving his thoughts but also his behavior, and attitude into the story and flourish it with his imaginations.

3. Short story

Short story is a brief tale which can be told or read at one sitting (Lawrence, 1917:277). A short story at least has seven elements; character, setting, plot, theme, point of view, and tone. But differ for other fictions, a short story will focus on only one incident, has a single plot, a single setting, a limited number of characters, and covers a short period of time.

In this study, the writer uses a short story from a famous horror author Edgar Alan Poe's "The Black Cat".

4. Edgar Allan Poe

Edgar Allan Poe is a short story, poetry, novel, and criticism writer in 19 century. He was born in Boston US, on January, 19th1809 and died on October, 19th 1849. His wife name was Virginia Elizabeth Clemm, they married when Virginia was very young. Edgar is one of an American writer who lived his life by writing. Even though many people recognize him as a horror and gothic writer but in 1800-1850 in England people called him as an American romantic writer. He released several stories that made him as a

gothic and horror writer one of them are "The black cat" whose people called as a mysterious story. In 1841, Poe published his book "Murder in Rue Morgue" who made him known as a father of detective writer. Until now many people still appreciate his works.

5. The Black Cat

The black cat is a short story by American writer Edgar Allan Poe. It was first published in the August 19, 1843, edition of *The Saturday Evening Post*. It is a study of the psychology of guilt, often paired in analysis with Poe's "The Tell Tale Heart". In both, a murdered carefully conceals his crime and believes himself unassailable, but eventually breaks down and reveals himself, impelled by a nagging reminder of his guilt.
