#### **CHAPTER V**

## **CONCLUSION AND SUGGESTION**

In this chapter, the writer provides the conclution of the study and she also offers some suggestions based on the data analysis.

## **5.1 Conclusion**

After analysing and then discussing about the errors committed by the students in writing descriptive text, it can be concluded that:

- 1. The errors made by the students were omission, addition, misformation and misordering. The number of the errors in grammar was 466. The frequency of errors in grammar was omission 229 (49.14 %), addition error is 13 (2.78 %), misformation error is 176 (37.76 %) and misordering error is 48 (10, 30 %).
- The most common error made by the students in writing descriptive text is omission then followed by misformation, misordering and then addition error.

# 1. For the teacher

## 2. For the students

The students should learn how to write a good text and focucesed on grammar especially tenses and the subject and verb agreement.
