CHAPTER I

INTRODUCTION

1.1 Background of the study

Language is believed to be the chief tool of communication with which one may express her/his idea, feeling, or emotion to other people. The ability to use language correctly is not attained automatically but it needs a lot of time and effort. Learners must be good at four skills namely listening, speaking, reading, and writing, likewise, they must be good at vocabulary, grammar, and pronunciation.

As one of the four skills, writing has traditionally occupied a place in most English language. In the classroom, writing may be used as one of the techniques to help the students to be interested in learning English. Students' writing can provide useful evidence of success or failures, or confusion. Having a good grammar system of a language, learners will be helpful in delivering their ideas, messages and feelings either to the listeners or readers.

Reid (1993:156) states that writing is usually easier, better, and more successful when drafting, revising, and editing together in the groups that are part of the writing process. Teachers have high responsibility to develop student ability in mastering language skill especially in writing. The teacher must create interesting activities in the class in order the students can develop their ideas in writing. Although the teacher provides some interesting activities it does not mean that there is no problem. The problem is how to increase the students writing ability. There are several types of writing students have to go through namely: argumentative writing, descriptive writing, expository writing and narrative writing. Based on the writer's experience, writing descriptive text is difficult to learn. The writer assumes that the difficulty is also faced by many students' particularly senior high school students. Descriptive is a type of text functioning to describe particular person, or thing and the students must use simple present tense in writing descriptive text. The students are also expected to use the spatial order in writing descriptive text.

1.2 Statement of the Problems

1.5. Scope and Limitation

This study is about writing. The writer focuses on analyzing the writing ability of the students. There are 5 elements of writing to be that assessed to measure the students writing ability, they are, grammar, vocabulary, mechanic, fluency and form. But in this study the writer only focused on three (3) elements they are: Grammar, vocabulary and form. The analysis is based on the criteria proposed by Hughes (1941).

1.6. Definition of Term

1. Writing

Text is a unit of organization of written language, which serves to indicate how main ideas in a written text are grouped (Mc Crimon, 1984:193). Text in this study is a descriptive text written by the students.

3. Descriptive

It is a type or part of writing that is arranged according to what it looks like or is where the object being described (Smally and Ruetten 1986). Here the students are expected to make descriptive composition about "their family".
